7.	25 July (Tuesday)	The Commission decides the representation within three days. 2 days ahead because of the 9 <sup>th</sup> and 10 <sup>th</sup> Muharram.	As Per Rule 18 (6)
8.	1 August 2023 (Tuesday)	<b>Any person aggrieved by the Decision of the Commission or, in case the Election Commission fails to decide the representation within the stipulated period provided, may appeal to the Regulator. The Decision of the Regulator in this regard shall be final.</b>	As Per Rule 18(7)
9.	4 August 2023 (Friday)	The Regulator to decide the Appeal. (10 Days) (Enhanced due to Independence Day and Saturday & Sunday 14 days)	As Per Rule 18 (7)
